#### 2024 HIGHLIGHTS

- **Responded to 1,744 inquiries** covering business resources, grants, and data requests across the region. This number increased from 1,661 in 2023.
- Worked with area governments and internet service providers on **continued Broadband middle mile infrastructure funding**. Region 9 is coordinating stakeholder collaboration meetings.
- Received \$1.33 Million in new grant funding to Region 9/SWCCOG including: \$999,999K (DOLA) for Broadband equipment; \$14,723 (SBA) Microloan and Technical Assistance; \$90K (USDA) Rural Business Development Grant for a regional biomass study; \$34K (DOLA) economic development training and databases; \$100K (State) Grant Navigator funds; and \$92,515.66 (USDA) RMAP Business Technical Assistance funds.
- Pending grants as of December 31, 2024 include: CDBG \$270K, CHIPS Market Study \$47K, and EDA \$434,863.24 for Broadband equipment.
- Successfully sponsored Lifting Up LLC as an Archuleta County Rural Jumpstart Business.

- **Staff presented at 34 meetings and community events** covering everything from housing, broadband, Enterprise Zone, Grant resources, businesses financing, and data.
- Held **quarterly Economic Development meetups** for economic development professionals in the region.
- Provided quarterly e-newsletter and monthly Grant Digest.
- With 99% of all goods transported in and out of the region by truck, Region 9 participated in the Four Corners Railroad Initiative studying the feasibility of a railroad spur line in Northern New Mexico.
- Region 9 and Region 10 EDDs coordinated a cross-region stakeholder group which completed a High Alpine Recreation study, now available on both websites.
- Worked with housing organizations around SB174 compliance, funding opportunities, **workforce housing builds**, and **start-up housing manufacturer business support**.
- Working on **2050 Regional Transit and Transportation Plan Update for CDOT** Region 5. Region 9 administers the Southwest Regional Transportation Planning Region (SWTPR).

#### **REGION 9 PROGRAMS**

Region 9 EDD administers the Southwest Transportation Planning Region, regional broadband, housing and transit initiatives. Other activities include business loans and financing, producing the region's Comprehensive Economic Development Strategy (CEDS), Grant Navigator services and data reports, Enterprise Zone Administration, facilitating the SouthWEST Opioid Response District (SWORD) and other special projects. Region 9 EDD also serves as the fiscal agent for several additional programs.

#### GRANT NAVIGATOR

Region 9 EDD received two years of funding to connect organizations to federal funding through our Southwest Colorado Grant Navigator. This position partners with governments and community organizations by providing research, editing, and grant writing to build capacity and accomplish priority projects. In the past year, our Regional Grant Navigator wrote and edited 23 grants, including 5 for the region and the rest for individual town/counties. **Funds granted to the region totaled \$1,881,344.** 

#### **SWORD**

Region 9 EDD facilitates the SouthWEST Opioid Response District (SWORD), formed as a requirement of the Colorado Opioid Settlement Memorandum of Understanding, to administer opioid funds in the region. The SWORD Council, facilitated by Region 9 EDD, has allocated opioid settlement dollars towards a regional recovery campus, and **funded \$438,256 in community grants.**

# **BROADBAND, HOUSING & TRANSPORTATION**

Region 9 EDD continues to accomplish priorities identified in the Southwest Colorado **Broadband** Roadmap plan (available on region9edd.org). Our work prioritizes the build out of middle mile infrastructure through equipment procurement, collaborative grant applications, and securing IRUs (Indefeasible Right of Use) to connect the region. The longer-term goal is to connect to the statewide Alpine Loop, and work closely with the Colorado Broadband Office on a statewide operations and management plan.

Regional **housing** coordination continues with agencies and organizations working towards land banking, water storage, and compliance with SB24-174. Additionally, the Point-in-Time Homeless Count will hopefully provide valuable data to inform future housing policies and funding applications.



Region 9 visits with regional government representatives and internet service providers regarding continued priorities for coverage and developing a Broadband Sector Partnership.

In **transportation**, continued coordination of the Southwest Regional Transportation Planning Region and transit stakeholders will shape the 2050 Regional Transit and Transportation Plan, ensuring alignment with CDOT priorities while addressing regional needs.

#### **ENTERPRISE ZONE**

Region 9 EDD is the Southwest Colorado Rural Enterprise Zone (EZ) Administrator and identifies businesses located within EZ boundaries, processes EZ tax certification forms, oversees the designation of EZ Contribution Projects, and certifies donor contributions. Businesses in the EZ boundaries are eligible for a variety of tax credits. Currently, all of Montezuma, San Juan and Dolores Counties, and sections of La Plata and Archuleta Counties, are designated EZ areas. All but La Plata County have also been designated as Enhanced Rural Enterprise Zones (EREZ) through 2026.

Area businesses that participated in the Enterprise Zone Tax Credit Program in 2024 reported **\$26M in qualified investments and \$1.01M in tax credits**. This is an increase from \$18M in qualified investments and \$556K in tax credits in 2023. The number of businesses participating continues to decrease decreased from 224 in 2024, 274 in 2023, and 279 in 2022.



## ENTERPRISE ZONE CONTRIBUTION PROJECTS

There were 27 designated Enterprise Zone Contribution Projects in the region. Two new projects were added, one renewed, four projects termed out, and two projects ended. **Projects generated a total of \$1.019M in economic activity through direct and in-kind contributions**. This continues a declining participation trends with last year's Projects at \$1.16M, 2022 at \$1.343M, 2021's \$1.46M; and 2020's 30 projects at \$2.35M. A decline in contributions was expected because several projects now fall under the Homeless Contribution Tax Credit Program, and many of our newly approved projects are smaller organizations.

## **BUSINESS LOAN FUND**

Region 9 EDD provides commercial loans to businesses for gap financing and start-up needs. Loan funding supports businesses in creating and retaining jobs, leveraging other funds, or exporting a good or service from the local economy. The Business Loan Fund (BLF) includes several Federal and State sources: Community Development Block Grants (CDBG) from the Colorado Office of Economic Development and International Trade (OEDIT) (contracted through La Plata County); the USDA Intermediary Re-lending (IRP) & Rural Micro Entrepreneur Assistance Program (RMAP); the Economic Development Administration (EDA); Start Up Loan Fund through OEDIT; Small Business Administration Microloan Program (SBA); Colorado State University Forest Service Wildfire Risk Mitigation Loan Fund, and revolved funds from previously restricted funds that are re-distributed in the community.











Since Region 9 EDD's loan program began, **\$46.4M** has been distributed to businesses throughout the region. Region 9 EDD had 220 loans receivable as of Dec. 31, 2024, totaling \$12.9M, an increase from \$11.2M in 2023 and \$10.3M in 2022. Region 9 closed 49 loans, creating 293 jobs in 2024; compared to 34 loans and 151 jobs in 2023; and 49 loans creating 443 jobs in 2022. Thirty-nine loans paid off in 2024, 21 in 2023, and 27 in 2022. Six loans were written off in 2024 and three loans written off in 2023. Since December 2020, Region 9 EDD has made loans to businesses outside of our five counties through several statewide initiatives.


Cumulative Loan Disbursement: 1990 - December 2024 Total = \$46,455,239



Loan Disbursement by County: January 1 - December 31, 2024 Total = \$4,572,458





Cumulative Loan Disbursement by County: 1990 - December 2024 Total = \$46,455,239


